Part I: General Application Information

1) HOME Overview

- a) The State of Texas receives an annual fund allocation from the U.S. Department of Housing and Urban Development (HUD).
- b) The HOME Investment Partnerships Program (HOME) is authorized by Title II of the Cranston-Gonzalez National Affordable Housing Act of 1990 (42 United States Code Sections 12701-12839) and the Federal HOME Final Rule at 24 CFR Part 92, as amended.
- c) This application is governed by the Texas Department of Housing and Community Affairs' HOME Rules at Title 10, Part 1, Chapter 23, Texas Administrative Code (TAC) in effect at the time the application is submitted.
- d) Additional or 'cross-cutting' Federal regulations cited in 24 CFR Part 92 must also be followed in administering any HOME Program Activity.
- e) The Texas Government Code §2306.111(c) requires that the Texas Department of Housing and Community Affairs ("TDHCA" or the "Department") expend 95% of HOME Program funds for the benefit of nonparticipating small cities and rural areas that do not qualify to receive funds under the Cranston-Gonzales National Affordable Housing Act directly from HUD. Five percent (5%) of the funds will be for the benefit of persons with disabilities who live in any area of the state.
- f) In accordance with Texas Government Code Chapter §2306.111(d), non set-aside housing funds awarded in the HOME Program must be allocated utilizing the Regional Allocation Formula (RAF) developed by the Department. Funds are allocated to urban and rural areas of each uniform state service region using a formula developed by the Department, known as the RAF.
- g) Applicants recommended for funding consideration and approved by the TDHCA Governing Board will execute a written agreement with TDHCA and will agree to comply with all statutory, regulatory, and other legal requirements applicable to the HOME Program as described in the application.
- h) TDHCA provides technical assistance to all HOME Program Applicants to ensure that participants understand the State and Federal regulations governing the HOME Program.

2) General Applicant Eligibility Requirements

- a) Eligible Applicants are Units of General Local Government (UGLG), Nonprofit Organizations, Public Housing Authorities (PHAs), and Councils of Government (COGs).
- b) Applicants are encouraged to familiarize themselves with the Department's certification and debarment policies prior to application submission. Please see 10 TAC §2.401
- c) All applicants will be subject to a Previous Participation Review by the Department.

3) Application Submission

- a) Applicants must submit a completed application, required documentation, and associated application materials, as described in the NOFA and as detailed in the Application Submission Procedures Manual (ASPM). All scanned copies must be scanned in accordance with the guidance provided in the ASPM.
- b) All Application materials including manuals, NOFAs, program guidelines, and applicable HOME rules, are available on the Department's website at <https://www.tdhca.texas.gov/home-application-materials>. Applications will be required to adhere to the HOME Rule and threshold requirements in effect at the time of the Application submission. Applications must be on forms

provided by the Department, cannot be altered or modified, and must be in final form before submitting them to the Department.

- c) For proper completion of the application, the Department strongly encourages potential applicants to review the State and Federal regulations, and contact the HOME Division for guidance and assistance.
- d) Audit Requirements. An applicant is not eligible to receive funds or any other assistance from the Department unless a past audit or Audit Certification Form has been submitted to the Department in a satisfactory format, per 10 TAC §1.403(d). This is a threshold requirement outlined in the application; therefore, applications that have outstanding prior audits will be disqualified. Staff will not recommend applications for funding unless the Applicant has successfully completed a previous participation review as outlined in 10 TAC §1.301.
- e) One copy of the Application in EXCEL format, and one copy of the Application including all attachments in PDF format and bookmarked must be uploaded to TDHCA's FTP server and received by the Department by the application deadline.

4) Application Limitations

Administrative funds for HRA, HANC and CFD are limited to 5% of the total Direct Project Costs, exclusive of Match. Administrative funds for TBRA have two options:

- a) Funds for Administrative costs are limited to 4% of the total Direct Project Costs, exclusive of Match funds, and Activity soft costs are limited to \$1,200 per Household assisted. However, an additional 1% in Administrative funds may be requested if Match provided meets or exceeds 5% of Direct Project Costs, or
- b) Funds for Administrative costs are limited to 10 % of Direct Activity Costs, excluding Match funds, and Administrator may not be reimbursed for Activity soft costs.

5) Application Review Process (Reservation Cycle)

- a) The process for application review is described in the HOME rules at 10 TAC §23.22. The NOFA indicates the approximate amount of available funds on either a statewide or regional basis. The amount of funding available by region and subregion is available for review at <https://www.tdhca.state.tx.us/home-division/home-reservation-summary.htm> . Funds set-aside for Persons with Disabilities (PWD), Contract for Deed Conversion (CFD), and Disaster Relief are not subject to the Regional Allocation Formula.
- b) In accordance with 10 TAC §23.22, Applications in response to the NOFA will be reviewed and processed in the order in which they are deemed acceptable for processing by the Department.
- c) The Department will ensure review of materials required under the NOFA and the application, and will issue a notice of any administrative deficiencies in accordance with 10 TAC §23.22. Note that administrative deficiencies that are not resolved timely may result in a termination of the Application.
- d) All Applicants will be processed through the Department's Application Evaluation System, which will include a previous award and past performance evaluation. Poor past performance may disqualify an Applicant for a funding recommendation, or the recommendation may include conditions.
- e) The Department may decline to consider any Application if the proposed activities would not, in the Department's sole determination, represent a prudent use of the Department's funds. The Department is not obligated to proceed with any action pertaining to any Applications that are received, and may decide it is in the Department's best interest to refrain from processing an RSP

Agreement. The Department reserves the right to request clarification on individual elements of any Application.

6) Administrative Deficiencies

- a) If an application contains deficiencies, staff may request that an Applicant provide clarification, correction, or non-material missing information to resolve inconsistencies in the original Application or to assist staff in evaluating the Application. The Department staff will request clarification or correction in a deficiency notice via an email or if an email address is not provided in the Application, by facsimile to the Applicant. Responses are required to be submitted electronically. The time period for responding to a deficiency notice commences on the first business day following the deficiency notice date. If an administrative deficiency is not resolved to the satisfaction of the Department by 5:00 pm CT on the fourteenth calendar day following the date of the deficiency notice, the application may be terminated. Applicants that have been terminated may reapply. Department staff may in good faith provide an Applicant confirmation that an administrative deficiency response has been received or that such response is satisfactory. Communication from staff that the response was satisfactory does not establish any entitlement to points, eligibility status, or to any presumption of having fulfilled any requirements. An administrative deficiency may not be cured if it would, in the Department's determination, substantially change an Application, or if the Applicant provides any new unrequested information to cure the deficiency.
- b) Pursuant to 10 TAC §23.23(a)(10) an Application must be substantially complete when received by the Department. An Application will be terminated if an entire tab of the Application is missing; has excessive omissions of documentation from the threshold or selection criteria or uniform Application documentation; or is so unclear, disjointed, or incomplete that a thorough review cannot reasonably be performed by the Department, as determined by the Department. Such Application will be terminated without being processed as an administrative deficiency.
- c) In accordance with §2306.082 Texas Government Code and 10 TAC §1.17, it is the Department's policy to encourage the use of appropriate Alternative Dispute Resolution procedures (ADR) under the Governmental Dispute Resolution Act, Chapter 2009, Texas Government Code, to assist in resolving disputes under the Department's jurisdiction. As described in Texas Government Code, Chapter 154, Civil Practices and Remedies Code, ADR procedures include mediation.
- d) Except as prohibited by the Department's ex parte communications policy, the Department encourages informal communications between Department staff and Applicants, and other interested persons, to exchange information and informally resolve disputes. The Department also has administrative appeals processes to fairly and expeditiously resolve disputes. If at any time an Applicant or other person would like to engage the Department in an ADR procedure, the person may send a proposal to the Department's Dispute Resolution Coordinator. For additional information on the Department's ADR Policy, see the Department's General Administrative Rule on ADR at 10 TAC §1.17.
- e) An Applicant may appeal decisions made by staff in accordance with 10 TAC §1.7.

7) Audit Requirements

- a) An applicant is not eligible to receive funds or any other assistance from the Department unless a past audit or Audit Certification Form has been submitted to the Department in a satisfactory format in accordance with 10 TAC §1.302. Staff will not recommend applications for funding

unless the Applicant has successfully completed a previous participation review as outlined in 10 TAC §1.303.

- b) Applicants are required to register in the System for Award Management (SAM). The SAM is the primary registrant database for the U.S. Federal Government. SAM collects, validates, stores, and disseminates data in support of agency acquisition missions, including Federal agency contract and assistance awards. Please note that the term "assistance awards" includes grants, cooperative agreements and other forms of Federal assistance. Whether applying for assistance awards, contracts, or other business opportunities, all entities are considered "registrants."
- c) Both current and potential Federal government registrants are required to register in SAM in order to be awarded contracts by the Federal government. You may register in the SAM at <https://www.sam.gov>

8) Performance Reviews and Sanctions

The Department may review and monitor the performance of Administrators in carrying out its responsibilities in accordance with the Contract, 10 TAC Chapter 23, the Final Rule and any other applicable Federal and State requirements.

9) Dispute Resolution/Appeal

- a) In accordance with §2306.082 of the Texas Government Code and 10 TAC §1.17, it is the Department's policy to encourage the use of appropriate alternative dispute resolution procedures (ADR) under the Governmental Dispute Resolution Act, Chapter 2009, of the Texas Government Code, to assist in resolving disputes under the Department's jurisdiction. As described in Chapter 154, Civil Practices and Remedies Code, ADR procedures include mediation. Except as prohibited by the Department's ex parte communications policy, the Department encourages informal communications between Department staff and Applicants, and other interested persons, to exchange information and informally resolve disputes. The Department also has administrative appeals processes to fairly and expeditiously resolve disputes. If at any time an Applicant or other person would like to engage the Department in an ADR procedure, the person may send a proposal to the Department's Dispute Resolution Coordinator. For additional information on the Department's ADR Policy, see the Department's Rule on ADR at 10 TAC §1.17.
- b) An Applicant may appeal decisions made by staff in accordance with 10 TAC §1.7.

Part II: Application Submission Format

1) Required Format

- a) Applications must be on forms provided by the Department, cannot be altered or modified, and must be in final form before submission to the Department.
- b) One copy of the Application in EXCEL format, and one copy of the Application including all attachments in PDF format, and bookmarked must be submitted electronically using TDHCA's FTP server as instructed in and in accordance with the application.
- c) Hard copy submissions are not an acceptable application format. Any hard copies received by the Department will be confidentially destroyed and will not be considered as an Application for the purposes of review or receipt of an Application.

2) Excel Application Document

- a) The application is an EXCEL Workbook and consists of a series of tabs. To complete the EXCEL workbook:
 - i) Fill out each tab to the best of your ability.
 - ii) Use the drop-down menu, when prompted, to answer questions.
 - iii) Some worksheets included in the workbook may not be applicable for the Activities you select on Tab 4: Program Activities. Enter Not Applicable/NA on any worksheets that are not needed.
- b) After you complete the application, save it as an excel document using the following format:
APPLICANT_NAME_RSP_Application.xlsx

3) PDF Application Document

- a) The PDF Application file is created by converting the EXCEL Workbook file to PDF format. The workbook can be converted using the following steps:
 - i) Click **File** in the menu bar.
 - ii) In the **File Name** list, type or select a name for the workbook using the following naming format:
APPLICANT_NAME_RSP_Application.pdf
 - iii) In the **Save as type** list, click **PDF**.
- b) Remember that there are tabs that require support documentation and/or signatures. Once you have executed all required documents and forms, scan them and insert the scanned documents and forms into the PDF application file, behind the respective tab. The Application must be the electronic PDF file created from the Excel file, not a scanned copy of the Excel or PDF file. Scanned copies of the Application are difficult to read, slow down the process for staff, and make it more difficult for applicants to review for completeness of the application prior to submission.

c) Creating Bookmarks

- i) After the Excel file has been converted to PDF and all executed forms have been re-inserted into their appropriate location within the file, you will need to create Bookmarks. To correctly set the Bookmark locations you must have the PDF file open in Adobe Acrobat. Click on the Bookmark icon located on the left-hand side of the Adobe Acrobat screen, or go to the task bar and select these options in the following order: **View → Navigation Panels → Bookmarks**.
- ii) If a Bookmark has already been created for each tab within the Excel file, simply re-set the bookmarks to the correct locations. To re-set the location for the Bookmarks, go to the first page of each separately labeled form/exhibit. You will then right-click on the corresponding Bookmark for the form/exhibit you are currently viewing. Select **Set Destination** and a pop-up box will appear asking you the following: "Are you sure you want to set the destination of the selected bookmark to the current location?" Select **Yes**.
- iii) If Bookmarks were not already created within the Excel file, then you will need to create these Bookmarks. Go to **Document → Add Bookmark**. Right-click on the first Bookmark and re-name it for the appropriate form or exhibit. You will then need to set the location of the Bookmark by going to the first page of each form or exhibit, right click on the corresponding Bookmark and select **Set Destination**. A pop-up box will appear asking you the following: "Are you sure you want to set the destination of the selected bookmark to the current location?" Select **Yes**.
- iv) If after conversion of the Excel file to PDF you have extra blank pages of any exhibit, you can delete those pages in order to limit the size of the file. To delete any extra, unnecessary pages identify the page number(s) you want deleted. On the Adobe Acrobat Task Bar click on Document and select Delete Pages from the drop down list. A box will appear prompting you to select which page(s) you would like to delete. Enter the page numbers to be deleted and hit **OK**.
- v) The PDF formatted file must be checked for the following prior to submission:
 - (1) Each tab must be correctly bookmarked
 - (2) Files should average less than 100 kilobytes per page
 - (3) Files must be readable with free PDF file viewers including Adobe Reader and be compatible with Adobe Reader 5.0 and above
 - (4) Files should be saved so that "Fast Web View" (or page at a time downloading) is enabled
 - (5) Text within the PDF file should be searchable using the "Find" command in the PDF viewer

4) Submission Procedure

One copy of the Application in EXCEL format, and one copy of the Application including all attachments in PDF format must be submitted electronically using TDHCA's FTP server. To submit via the FTP server, go to the following website and use the username and password below

Part III: Application Procedures and Contents

1) Application Procedures

- a) Each RSP application for HOME Single-Family Programs contains general applicant information, the cash reserve threshold requirement, and Activity specific information, including additional threshold criteria.
- b) Additional documentation requirements are only required to be present on the PDF Application Document and the following paperclip symbol will ALERT you 

2) Description of Tabs

- a) **Tab 1: Applicant Information.** This tab requires general information about the Applicant. Complete all highlighted fields. **If applicable**, place Indirect Cost Rate support documentation behind Tab 1.
- b) **Tab 2: Project Oversight.** Applicant must answer all questions as additional questions appear based on affirmative answers to some questions.
- c) **Tab 3: Administrative Forms.** Required forms for all Applications as described in the Application must be submitted behind this tab.
- d) **Tab 4: Program Activities.** Applicant must select the Program Activity or Activities which Applicant plans to administer as an RSP. TBRA Only: select only one option for administration costs.
- e) **Tab 5: Documentation of Financial Capacity.**
 - i) Adequate cash reserves are a threshold requirement for all applications and are not considered matching funds. Cash reserves up to the maximum amount required for any application submitted under the NOFA is reported on this tab. Additional documentation must be submitted behind the tab as further described in the Application.
 - ii) In accordance with 10 TAC §1.406, the Department requires that nongovernmental program Administrators of federal or state funds maintain adequate fidelity bond coverage, indemnifying the program Administrator against losses resulting from the fraud or lack of integrity, honesty, or fidelity of one or more of its employees, officers, or other persons holding a position of trust. The fidelity bond must be for at least the greater of \$50,000 or 10% of the total funds reserved and must be submitted behind this tab for review.
- f) **Tab 6 a-k: Applicant's Service Area(s).** The Application will encompass specified service area per activity type. The service area may be amended upon request.
- g) **Tab 7 a-k: Matching Funds.**
 - i) Each Application must meet the tiered Match requirement per Activity. Applications proposing Match in amounts that do not equal or exceed the Threshold requirements for the Activity type selected may be terminated without further review. Threshold Match Requirements are found in 10 TAC Chapter 23.23(a)(5) for HRA and HANC. Match is not required for TBRA, but may be provided in accordance with 10 TAC 23.27(j)(3) in order to qualify the entity for additional Administrative funds of 1%. Match is also not required under the Disaster Relief and Persons with Disabilities set-asides.
 - ii) To be considered eligible Match, a contribution must be properly documented, must be a permanent contribution to the HOME project, and must not be federally sourced. Match

- must meet the requirements of 24 CFR Part 92 and 10 TAC Chapter 23. Please review [TDHCA's HOME Single Family Match Guide](#) for information on the match requirement.
- iii) **HRA and HANC Matching Funds.** Matching funds are a threshold requirement for HRA and HANC. Applicants must list all **anticipated** sources of Match on this tab. Match that is shown on the tab should be supported by documentation submitted behind the tab. The source of the Match contribution may change after a contract is awarded under the NOFA, but the total Match contribution pledged in the Application will be contractually required.
- For HRA and HANC:** Match is determined by population. Please refer to the HOME Rule for requirements. To obtain the correct population information and to determine the required Match percentage for submission, applicants should include the census information from the U.S. Census Bureau's most recently available American Community Survey (ACS) data, or include estimates from the U.S. Census Bureau's QuickFacts if applicable. This data provides Demographic and Housing Estimates. (For assistance in utilizing these websites, please contact the HOME Division: HOME@tdhca.texas.gov.) Applicants that charge customary fees related to the construction of HOME single-family housing **must waive those fees, regardless of whether there is no Match obligation (0%),** and Applicants must submit their schedule of fees behind this tab. The maximum Match contribution for any Applicant is 25%.
- iv) **TBRA Administrative and Matching Funds:** In accordance with 10 TAC 23.27(j)(3), applicants must elect how they want to receive administrative funding. Also, Match is not a requirement for TBRA, however Applicants are encouraged to provide Match. Applicants must list all anticipated sources of Match on this tab. Match that is shown on the tab should be supported by documentation submitted behind the tab. The source of the Match contribution may change after an RSP Agreement is awarded under the NOFA, but the total Match contribution pledged in the Application will be contractually required if increased Administrative funds for TBRA are awarded based on the Match pledged at Application.
- v) **CFD Matching Funds.** Match is not a threshold item for CFD.
- h) **Tab 8: Previous Participation.** This tab requires submission of the Previous Participation information more thoroughly described in the Application.
- i) **Tab 9: Affirmative Fair Housing Marketing Plan & Waitlist and Client Selection Policy:** Applicants must submit an Affirmative Fair Housing Marketing Plan in accordance with 10 TAC 20.8(d) and a Waitlist and Client Selection policy in accordance with 10 TAC 20.8(c).
- j) **Tab 10: Language Access Plan.** In accordance with 10 TAC 20.8(i), this tab requires submission of the Language Access Plan that ensures persons with Limited English Proficiency (LEP) have meaningful access to services, activities, programs, and benefits. An LEP person is someone who is not able to speak, read, write, or understand the English language at a level that allows for effective communication with staff.
- k) **Tab 11: Resolution.** Submission of a resolution which includes all provisions listed in the Application and at 10 TAC §23.23(2)(a-e) is a threshold requirement for all Activities.
- l) **Tab 12: Mortgage Production Housing Counseling.** **If applicable,** Applicants must provide information about the Applicant's compliance with the S.A.F.E. Mortgage Licensing Act of 2008 as well as their Homebuyer Counseling program, including the certification of the trainer.
- m) **Tab 13: Self-Sufficiency Plan.** **If applicable,** Applicants must describe the Self-Sufficiency Plan for the TBRA program. The Self-Sufficiency Plan must contain information about transition of tenants towards self-sufficiency, and towards obtaining permanent housing (either assisted or unassisted) before the end of the 24-month term of assistance to the household.
- n) **Tab 14: Certificate of Applicant.** The tab must be executed by the Applicant's signature authority.
- o) **Tab 15: Application SELF-Checklist.** Applicants should verify on the application checklist that all

applicable criteria are included in submission.

- p) **Tab 16: Application Reference Material.** Application reference website links to assist in completion of the application.
