Proceeds of the Bonds will be loaned to Airport Commerce LIHTC, LLC, or an affiliate thereof (collectively, the "Borrower") to provide financing for an affordable multifamily housing development (the "Development") located at approximately 1501 Airport Commerce Drive, Austin, Travis County, Texas 78741. The Borrower is the initial owner and principal user of the Development.
