Dear PFC User:

The Texas Department of Housing and Community Affairs (Department) received documentation on May 13, 2025, addressing the noncompliance identified during the review of the Audit Report submitted by Novogradac & Company, LLP on January 20, 2024. Corrective action was due on May 13, 2025.

The documentation submitted was sufficient to correct the noncompliance related to **Failure to comply with the Public Facility Corporation Regulatory Agreement** affecting unit 624 and set-aside requirements for 2 bedroom/2 bathroom units at 80% AMI. The documentation was also sufficient to correct noncompliance related to the **Households above the income limit** affecting units 328, 331, 738, 917, 118, 1036, 1234, 1334, 1515, 1534, 1625, 1711, 1721, 1932, 2038, 2221, 2225, 2317, 2327, 2417, 2424, 2525, and 2527. Please see the attached Finding Report for details.

The noncompliance related to **Failure to comply with the Public Facility Corporation Regulatory** affecting set aside requirements for 2 bedroom/2 bathroom units at 60% AMI and 2 bedroom/1 bathroom units at 80% AMI, as well as **Gross rent exceeding the highest rent allowed under the Regulatory Agreement** for units 328, 331, 738, 1217, 1228, 2221, 2238, and 2518 has been dropped.
