The Texas Department of Housing and Community Affairs (Department) received documentation on August 26, 2025 addressing the noncompliance identified during the review of the Audit Report submitted by Stephanie Naquin on May 30, 2025. Corrective action was due on August 26, 2025.

The documentation submitted was sufficient to correct the noncompliance related to **Household above the income limit** affecting units 1914, 525, 838, 1117, 1511, 1515, 1615, 1628, 1636, 2015, 2111, 2113, 2327, 2337, 2616 and 2638, **Failure to comply with the Public Facility Corporation Regulatory Agreement** affecting units 232 and 2327. Please see attached Finding Report for details.

The noncompliance related to **Household above the income limit** affecting units 328, 1222, and 2634 has been dropped.

Please note, the noncompliance outlined above is considered corrected during the corrective action period. The Department considers this review closed.

The next annual Audit Report is due June 1, 2026.
