The Texas Department of Housing and Community Affairs (Department) received documentation on September 14, 2025 addressing the noncompliance identified during the review of the Audit Report submitted by Stephanie Naquin on June 30, 2025. Corrective action was due on September 14, 2025.

The documentation submitted was sufficient to correct the noncompliance related to **Gross rent exceeds the highest rent allowed under the Regulatory Agreement** affecting unit 112, **Failure to comply with the Public Facility Corporation Regulatory Agreement** affecting unit 223, **Household above the income limit** affecting unit 320, 708, 926, 112, 114, 221, 223, 321, 411, 505, 618, 701, 705, 716, 723 and 727. Please see attached Finding Report for details.

The noncompliance related to **Household above the income limit** affecting unit 708, **Finding Two** affecting unit(s), **Gross rent exceeds the highest rent allowed under the Regulatory Agreement** affecting unit 223, has been dropped.

Please note, the noncompliance outlined above is considered corrected during the corrective action period. The Department considers this review closed.
