- 102 Of course, thank you for having me once again my name is Matthew Lovitt, I'm the senior legislative
- 103 affairs advisor here at TDHCA standing in for Michael Lytle this morning what I plan to do is just provide
- a brief general update on what happened in the legislature as it relates to TDHCA then also talk
- specifically about those that relate to homelessness or legislation that relates to homelessness.

- 107 So generally speaking there are a few significant pieces of legislation that passed during the 89th session
- 108 that impact TDHCA directly HB 21 by Representative Gates concerning housing finance corporations SB
- 109 243 by Senator Flores concerning migrant labor housing and SB 2137 by Senator Menendez. Concerning
- 110 low income housing tax credit.

- 112 I'm happy to give you more information about any of those bills or any of the. Bills that I can think of
- 113 maybe after the meeting but just generally speaking the idea being for this legislative session is to really
- 114 improve oversight and enforcement of some really critical housing funding the housing mechanisms
- 115 here in the state of Texas whether it be HFC's or Migrant labor housing or the low income housing tax
- 116 credit program really great stuff really excited to start implementing those things and just to really
- 117 improve the housing ecosystem here in the state of Texas.

- 119 Specifically as it relates to the TICH the primary piece of legislation that passed was not really a piece of
- 120 legislation at all but Rider 16 I don't know if you guys had an opportunity to look at the general
- appropriations act if not I've brought copies of the rider 16 language for you to review at your leisure
- but primarily what this bill. This rider does and actually let me back up it was authored by
- 123 Representative Lauren Simmons out of South Houston.

- 125 She filed a bill similar to rider 16, HB 2142 that bill did not get out of committee so she settled for Rider
- 126 16 which is more or less accomplishes the same thing that she was hoping to accomplish with HB 2142
- 127 which is a study on homelessness services here in the state of Texas specifically partnerships between
- 128 the TDHCA or the state and institutes of higher education local governments and private entities excuse
- me to serve people experiencing homelessness, the use of small dwelling units or tiny homes for this
- 130 particular product. As well as leveraging the institutes of higher education to provide community
- 131 services.

- 133 Like I said there is a study so there will be a study conducted well TDHCA will be contracting with a 3rd
- party to conduct this study there will be a report associated with that that study and it is due December
- 135 31st of 2026. I'm sure it will be made publicly available shortly thereafter.

137 Does this impact K-12 or McKenney Vento students?

139 I do not know the answer to that I can certainly find out.

- 143 Yeah, I remember talking to them about the bill that that is related to this and I don't think that they
- 144 were including that population then but they don't they don't exclude that population so it could
- 145 definitely.

- 156 Before I ask Matthew my question any other questions on the legislative updates? Can you brief me on
- 157 Senate bill 2623.

- 163 Well I mean it didn't pass yeah they did not pass because I wrote you about the bill yeah.

- 165 That's all I need to know, that's all I need to know about it but I never heard the

- 167 Oh I'm sorry yes.

- 169 Resolution of it and PNS and union gospel are Ringing my retired phone off the wall.

- 171 Are they still? OK well I can contact them and let Them know.

- 173 No, I'll do it I'm sorry.

- 175 OK yeah no it actually was never it was. It got stuck in Calendars yeah so it didn't make it but then SB
- 176 241 came up for a hearing or came up for on the floor.
- 177 And they there was an attempt to add some of the language from SB 2623 to 241 and.

- 179 Can you provide more context for these bills? Like what they did?
- 180 **10:06 Eric Samuels**
- 181 OK.
- 182 **10:09 Eric Samuels**
- 183 All right so SB 2623 it would be what they call the school safety bill and what it would have required is
- 184 that homeless navigation services be X number of feet away from a daycare or school or a park, it even
- got to that point it would require that and if a program was operating within that that.

- 187 Yeah yeah.

- 189 They could be fined and then closed down for a short time I'm really simplifying it but that's yeah that so
- 190 that and So what we did is we talked to legislators throughout the throughout the capital that we talked
- 191 to them about the fact that there were hundreds programs that would have fallen under this.
- And programs that had been there for a very long time and programs that worked really closely with schools that they were close to and so it just became a unpopular bill because of that.

- 197 The agency that it was written for I believe will be moving anyway away from the school that it is close 198 to it's in South Austin so hopefully that bill won't come up again yeah so yeah that's.

- 202 Yeah.
- 203 11:31 Mike Doyle
- Star Telegram did a big deal of it that Union Gospel is going to have to close down, Presbyterian night
- shelter is going to have to close down 1400 people hit the street out you know. So I was told could you
- find out when you're in Austin?
- 207 And so.

- 209 Can't say it won't come back but I don't think it will.

- 211 Not for a couple of years.
- 212 11:51 Eric Samuels
- 213 Not for a couple of years I don't know.

- 215 And I'm already gone by then.
- 216 11:55 Eric Samuels
- 217 And then SP 241 with a strength in the city wide camping ban. And that there was an amendment to add
- the school safety zone on top of that and it did not pass it failed.

- 219 There was a point where your order that came up and the author withdrew it.

- 225 OK we've got through that I thought that was going to take a while.

227 Member agency updates TDHCA I guess Rosie your first or is that. Yeah.

228 12:34 Rosy Falcon

- 229 Yes Sir, ok so I have a few updates for you all we are we've received our 2025 funding allocation this
- 230 year we got a slight bump in it about \$500,000.00 or so, our allocation for the state was \$10,308,471.

231 12:54 Rosy Falcon

- Our NOFA was already released and the amount for the NOFA was \$9,844,590 844.00 and there is a
- table that was out here that yes that one has our breakdown. So those are the final numbers that you're
- looking at. So a little bit that I'll talk about here isn't necessarily coinciding with those numbers but I will
- 235 get there. So initially for the NOFA for the \$9.8 we withhold 75% as is set aside for continuing awards.

- 237 So that amount is not reflected immediately as available for competition, but it could trickle down to
- that second competition which is our regional. This year we had approximately out of the \$7.3 that we
- earmarked for the 75% set aside we were able to use \$6.8.

- But and so again roughly about \$500,000 got transferred over to the regional competition that's why the
- numbers you're looking at there are slightly different than the percentages I'm kind of sharing right now.

- OK and so again for those that just to reminder are continuing awards we do set aside a hefty amount of
- the allocation but that's just to ensure continuity for high performing sub recipients and so this is the
- 246 way for the sub recipients that are showing some data-driven results that are producing around the
- 247 state throughout the now 12 CoCs.

- 249 To ensure that they can continue business without waiting for the summer to figure out if they're going
- to get funded how much they're going to get funded for, so we this year have 35 I believe, yes 35 eligible
- subrecipients and we contact them early on so around April is when they know if they're going to be

- eligible for continuing award unfortunately this year they were taking it on faith that we will let them
- 253 immediately because we didn't have an allocation amount and so we talked to them about different
- 254 scenarios what would happen.

All of them agreed to continue on this and continuing award and so that's how we ended up at the \$6.8

- 257 million we did have I believe 3 CoCs that did not have any eligible continuing awards and then on your
- table that is why the zero is designated on there and that's 624, 625 which is a new CoC and so because
- of the rules our main factor that initially determines who's eligible or not is they have to have received
- or been awarded and accepted 3 out of the last 4 annual allocations since this since there this is their
- 261 first funding year they will be in the regional competition for a bit. Then 701 Bryan/College station
- Brazos Valley they also did not have somebody so all of that allocation got moved over to the regionalcompetition.

- And so the regional competition starts out with 25% of the allocation that's on the NOFA but now it's 3 a
- little bit over \$3,000,000 to compete for those that do not have a continuing award and so this section is
- 267 reserved so that we could encourage new sub recipients to come and provide services.
- 268 So still allows for some new agencies that perhaps want to join our allocation of the ESG and so that
- 269 closed Monday so we are busy the homeless programs team and some of the HOME personnel helps us
- with this so we can get out notices as early as next week they're reviewing them we received 79
- 271 individual applications. Since 79 are per component.

- 273 So that made-up roughly 56 organizations so we've got 56 new organizations some are continuing that
- we fund continually but aren't eligible yet for continuing award and then some are brand new we do
- have an applicant for the Lubbock CoC we met with Abigail Versyp and myself met with them.

- 277 Early on and explained to them the whole process and the allocation that's geared for them and they
- were very helpful at getting somebody in their COC to apply this year and so we're happy to report that
- that amount is going to be earmarked for them if they do end up being successful applicants and then
- we did have one CoC that we did not receive any applications for and so that amount will get swept over
- and that was the 604 Waco so the \$113,152 is going to get swept to the statewide competition.

- 283 The next thing for this allocation is or the next event is our tiebreaker which is set for July first and then
- we can I can share the link with Jeremy and then someone can send it out if you're interested. We it's
- short it takes we set it for an hour but it takes about roughly 30 minutes and it's just so the public can
- see us and how we determine randomly generated numbers to give each of the applicants and so
- everybody gets a tiebreaker number and we do that publicly so that everybody understands the process
- the reason for that is we are with tighter money we're getting more competitive and sometimes we do
- 289 have applicants that have the same high-ranking score the tiebreaker number would determine who

- 290 gets that and so it's determined by whoever has the highest tiebreaker score and we have used a couple
- of times in the last 2 competitions. Awards have been decided based on that tiebreaker so it's July first
- from 1:00 o'clock to 2:00 o'clock and then we'll share that link a listserv has already gone out. But we'll
- share a link again to everybody here that gets the distribution e-mail in case you want.

- 295 Sign up we don't we don't add that to our website after but we do add the roster of all the results on the
- 296 website so it is there it will have each applicant their self-score and the tiebreaker number and then
- finally just briefly covering the statewide competition since we know for sure we're going to have money
- allocated for it.

- Technically most of the time we don't know until the very end if we're going to have money and that's determined based on how many successful applicants are in each CoC so whatever is remaining.
- 302 Unless the remaining balance is under \$30,000.00 that gets swept over to a statewide competition, it's
- not a new time to submit applications what we do is we take fall successful applications that were

304 unfunded or recommended for funding at the regional level and then we rank them from the highest

305 score to the lowest and we start.

- 307 We started a funding them or recommending funding from the until we run out of money and this is
- regardless of CoC so any high-ranking within the CoC 's that didn't get funded go into this pool and then
- 309 we stopped when we run out of money or if the highest ranking is emergency shelter street outreach
- 310 and we've reached the statewide 60% cap.

311 20:00 Mike Doyle

- 312 Question about that.
- 313 20:01 Rosy Falcon
- 314 Mm-hmm.
- 315 20:02 Mike Doyle
- Assuming that the pool is \$400,000.00 this year a new applicant applies for it and is awarded funding for it.
- 318 Is there a possibility that it would go away next year if the pool goes down?

319 20:21 Rosy Falcon

- 320 So, if they're brand new their award technically would go away because it would have to reapply they're
- not eligible for continuing award yet until they get funded 2 more times whether it's through the
- 322 regional competition or the statewide competition.
- 323 20:36 Rosy Falcon

- But the pool only comes into play to determine how many unfunded we can fund in that moment in
- time it isn't guaranteed from cycle to cycle because it's only the remaining unused funds what our goal is
- to disseminate all that money to the CoC's because they're based on demographics and need for each of
- those regions. And so we want to keep that money in that region before we move it to that statewide.

329 OK. Thank you.

330 21:06 Rosy Falcon

331 OK and then our next one it's just a brief update on ESG RUSH and that's our rapid unsheltered survivor

housing program that is the new HUD program to its goal is to supplement assistance to those that are

affected by natural disasters and so Texas and were declared there was a declaration back the last time

- that we met we covered the first allocation which was roughly around \$1.8 million we did receive a
- 335 second allocation.

337 The allocation came as a new award to the state and so we are going to provide those to current existing

RUSH sub recipients only the eligible counties did not change and so we're still within the 5 CoC 's and

we only received about \$218,000.

340 21:58 Rosy Falcon

341 So we're making \$209,000 of that available to sub recipients. So we're looking at potentially 5 additional 342 awards for the rush funding.

343 22:10 Rosy Falcon

And then my last update is for our homeless housing and services program or HHSP I know there was a
lot of potential movement in this last session but we did end up with our program somewhat intact our
allocation for the first biennium is \$6.499 million so a little bit under \$6.5.

348 It seemed like an increase but that's because that's where the \$200,000.00 for the feasibility study goes

in so we didn't lose anything out of the HHSP allocation since that for that biennium they increased it by

350 the \$200,000.

And the way that's going to breakdown is the youth set aside gets the set \$1.5 million and the general set aside goes sub slightly from the last biennium to \$4.7 million.

- 355 We remained with the 9 eligible cities we end up with 10 sub recipients because haven for hope
- administers directly San Antonio 's general set aside and so that the 9 city which is San Antonio they
- 357 break into 2 sub recipient contracts with us.

- And then of course the population stayed the same at 285,500 we've got one city that is teetering on
- the lower side there are about 3000, a loss of about 3000 in population will take them out and then of
- 361 course we've got 3 of those.

- 365 Plano.
- 366 23:38 Rosy Falcon
- 367 Yeah, and then we've got the 3 cities that are coming near in there which were Lubbock, Irving and
- 368 Laredo are the ones that are they're close to the 285,500 but they would have been brought in had it
- been lowered to 250,000 but they're still kind of close with the with the requirements we have now.

371 Which that was one of the bills that did not pass

- 373 To increase the population threshold or lower?
- 374 24:03 Rosy Falcon
- 375 Decrease and that those are my prepared remarks but any questions.

- 377 Question for Rosy? Other than me.
- 378 24:16 Eric Samuels
- 379 I may have a question for you later regarding Lubbock but I'm trying to find out some things.

- 381 Sure.

- 383 Was blown off the map? Well the one free actually blew down. So there's no covering.

- 385 There's plenty of wind out there.

- 387 So my question is have you heard. Because rumors are going around North Texas that there's going to
- be. In the future allocations directed at kids aging out of foster care and have you heard anything any
- rumors of that because one organization in particular is trying to build a big facility for kids aging out of

- 390 foster care an apartment complex type of thing and tell him the better wait until you know they're going
- 391 to be any vouchers.

- 393 There was something in the session but I don't think it.
- 394 25:02 Multiple Speakers
- 395 [Overlapping conversation]
- 396 25:19 Eric Samuels
- 397 Yeah Lauren I know was working on. That TNOYS had a bill that would have helped get that we.

398 25:25 Brooke Boston

- 399 I would note that tdhca is going after FYI vouchers which are foster youth we've set up a relationship
- 400 with DFPS and they do a referral to us and then. It's not a very efficient program from HUD.

401 **25:43 Mike Doyle**

402 Is there one? An efficient program with HUD?

403 25:49 Desiree Viramontes

- 404 That's been in place for a long time though right?
- 405 25:52 Brooke Boston
- 406 Yes but that Texas hasn't necessarily been.
- 407 25:54 Desiree Viramontes
- 408 As great about it OK.

409 25:56 Brooke Boston

- 410 Yeah, we hadn't like TDHCA as a PHA had not been pursuing it. And so we now as a PHA are doing that
- 411 and then DFPS refers us to you know.
- 412 26:04 Desiree Viramontes
- 413 Nice. How many vouchers is that Going to be?

414 26:10 Brooke Boston

- 415 It's not a number of vouchers so that's the quirky thing about FYI there was a competitive pool and we
- did not do that one because we didn't want to get told let's say we had 20 vouchers and then we
- 417 couldn't fill them in it look like more satisfying it we alternative method was that you could just turn in
- 418 your voucher request every time you have a candidate.

420 Oh

421 26:31 Brooke Boston

422 Oh and then when you got that youth is in a voucher and their house when it recycles we don't have to

423 keep going back to HUD to ask for it so it's kind of like as you ramp up.

424 26:41 Desiree Viramontes

- 438 What was the ISD I mean Fort Worth Police Department has contracted the local agencies starting to
- 439 engaging kids in foster care at age 15 so that when the age out they know exactly how to go get a
- 440 driver's license or how to do these kind of things because the follow up the day after there's 17/364
- birthday when they're gone they don't know what to do and they come to organizations all over what
- do I do and the Police Department determined that that's the fastest growing criminal population in the
- city is foster kids aging out of foster care and one of the reasons they've identified as access toresources.

- there and this is through the one time allocation for the Fort Bend Youth Grant for \$1,000,000.00 to try

- 462 To identify individuals or any that would qualify for that use money and they're working right now with

- 466 conference to bring everybody together, and be able to say hey you are already providing services for

- 505 mentor with lived experience to support them in knowing about the supports that are available to them
- and then specifically around FYI and yeah we're grateful to see the interest in in that.

- 508 Right now that we have the HUD grant for statewide across Texas that is the youth homeless systems
- 509 improvement grant which part of that is creating those collaborations with you know justice and foster
- 510 care as well as housing we have several big projects that that the TICH supported us on so that was
- awarded this last year we're grateful to know that we still have that full funding for the rest of the grant
- 512 term but statewide tiers will be doing regional capacity building meetings specifically around, they are
- 513 very specific areas specific around these intersections that were all speaking around yeah higher
- education K through 12 juvenile justice DFPS child welfare housing and we actually have one coming up
- 515 in the Fort Worth area in August, and then also they explain is going to be in San Antonio and we'll be
- 516 doing them statewide like Tyler and Amarillo other places like that so I can send that information out
- that that is around creating a more coordinated approach to use because as we've all talked about many
- 518 young people don't know the services that are available to them and.

So yeah hi good morning and mine shouldn't take too long I'm Peg McCoy and I'm filling in for my bossNaomi Cantu.

- 536 I'm going to be talking about the American rescue plan just as a quick recap HOME instead of we have
- 537 lots of acronyms too but HOME-ARP program the majority of our one-time funding into rental
- 538 development and in the non-congregate shelter funding we were allocated about \$130,000,000.

- 540 And about half of that went into rental and happened in non-congregate shelter development and
- another \$4,000,000 into nonprofit capacity building and operating assistance.

542 35:25 Peg McCoy

- 543 For the rental development side we've awarded all of the \$53,000,000 in funding per units and 12
- 544 different developments and 4 of which have actually opened up and have opened and 3 of those are in
- 545 Austin and one is in Dallas. Our non-congregate Shelter funding is paired with our nonprofit capacity
- 546 building and operating assistance funding.

547 35:51 Peg McCoy

- 548 So organizations must first be awarded nonprofit capacity building and operating assistance before they
- 549 can apply and receive a non-congregate shelter award you can find the application log on that handout
- 550 you can see that we've awarded.

551 36:12 Peg McCoy

552 The other ones foundation in Austin, nonprofit capacity building and operating assistance through an 553 invitation to apply back in 2023.

554 **36:23 Peg McCoy**

555 We're a little over \$3,000,000.00 and currently we're in the process of reviewing their non-congregate 556 application for \$50,000,000.00.

557 36:34 Peg McCoy

- 558 Was submitted back in December of 2024 at the last meeting Naomi spoke about an open competition
- 559 NOFA an open NOFA that's competitive I should say we had for the nonprofit capacity building and
- 560 operating assistance?

561 36:52 Peg McCoy

562 And the application acceptance period for this NOFA just closed earlier this month on June 7.

563 36:58 Peg McCoy

- 564 And we've received 8 applications and are working through their scoring of evaluations in this one
- there's a total of \$750,000 in nonprofit capacity building and operating assistance available and for
- about in about \$14,000,000.00 for the award year were used to apply for non-congregate shelter
- 567 funding so it's again it's kind of they have to get the capacity building and then you're able to apply for
- the non-congregate shelter the funding available for non-congregate shelter may increase depending on
- the current 2 NCS application review and we plan to award the NCO which is nonprofit capacity building
- and operating assistance in the fall of this year.

605 Eric Samuels Texas Homeless Network. The non-congregate shelter that other the other ones 606 foundation that \$50,000,000. That is to build several more units correct?

- There should be a total of 325 units 225 which would be additional tiny homes it's a 7 acre development
- and then there's a 4 story building with another 100 like a headquarters building that will have kind of a
- 610 Community Center on the bottom and units on the top office space.

- 612 Which is good because I don't know if you've been out there but they've been in a trailer so yeah.

623 Efficiency apartment unit where they're all self-contained be a non-congregate shelter.

- 625 It would the definition the interesting definition about these units is that they have to have a bathroom
- 626 in them so it's a room with a bathroom they don't have to have a kitchenette but they need to have a
- 627 shower and a toilet so like for example on this Sam ministries application there they're going to do
- 628 would like to do a hotel conversion and so that's considered non-congregate shelter the other half of
- the unit set filled with the with the county on the other side of the 200 units they have on the on the
- 630 ground there wouldn't actually, be eligible for this funding because they don't have or something similar
- that wouldn't because they don't have a separate bathroom so yeah kind of.

- it's either that the biggest those are 2 distinctions you can't have a lease and so they're not tenants and
- 659 you can't and it needs to have a bathroom.

- 669 Texas rent relief program and then a small portion was set aside why say small is actually big but of
- 670 course soon of the funds were put towards housing stability services which is targeted almost
- 671 predominantly towards homeless or at risk of homeless.

- 573 So just wanted to kind of give an update we have spent \$220,000,000 in that program from May of 2021
- to September 2025. It has gone to 59 subrecipients across the state and they've served 130,000 peoplealready.

- 677 Assistance can be for anything from housing navigation, addiction prevention, legal services, rent
- 678 deposits, pet deposits, utility deposits, landlord incentive, so that program will continue through
- 679 December and that's when the ERA funds expire.

- 681 We are it's very fine-tuned very finely managed to by Cate Tracz and she anytime she thinks one sub
- 682 recipient isn't going to hit it, like she watches their expenditures every month now and if it looks like
- someone 's not going to meet it she de-obligatess from that one and pushes it somewhere else so I think
- 684 we're going to have spent down almost to the penny.

- 898 Data well it's annual so over the course so it'll be more than the point in time count if we just took a
- 899 point in time picture. With that data it wouldn't because it doesn't include victims of domestic violence
- 900 this is just data out of HMIS yeah and it doesn't include some youth as well.

- 902 OK I'm just. Well Yep I'm wondering if there's sort of like a big delta between the point in time count
- 903 date data and this more accurate data. If you're going to have to kind of explain things people are saying
- 904 well why is there such a huge uptick in homelessness and you know with this dashboard versus what
- 905 we're seeing in Point in time count?

- 907 Yeah, well yeah how we explain that as it's a cumulative count you know people fall in and out of
- 908 homelessness So what I would rather look at is the numbers of people that have fallen into
- 909 homelessness for the first time and compare that year to year.

- 913 Yeah. I was just concerned if you were going to have run into problems like communicating this if people
- 914 because we've been all kind of used to well this is the annual point in time data this is kind of what we
- 915 wrapped around our heads is the number of people experiencing homelessness and then all of a sudden
- 916 if we have a dashboard that's showing way more people.

- 918 Yeah, yeah I we try to explain that on the only took the last 2 slides of that slide deck in the earlier slides
- 919 that we do talk about that. Yeah we just try to point out that these are two different things the point in
- 920 time counts that one time sentences this is a you know a long term cumulative count and picture of
- 921 homelessness.

- 923 Desiree with TEA that annual is how we do it so we do like our own kind of point in time count with
- 924 October snapshot for the numbers and then we also gather that data for the entire year and report that
- to the Department of Education so when I look at that I'm like yes that makes total sense but having
- 926 both views for both worlds that look at it might be A really good thing.

- 930 We have that data if they're in shelters you know.

932 Yeah, but you don't have like the larger because 80% of our numbers are doubled up in.

- 934 The yeah we can't we don't count those doubled up but we do I would love to find an easier way to
- combine the pit with that we can do it annually but you know it's hard to do it on a on a day by day basis
- so. I Probably didn't answer your question by but hopefully somewhat yeah OK good yeah.

940 Eric, I had a question for you too the agreement that you are looking at doing with UT what are they

- 941 going to be doing for that?

- Right So what they will be doing is working with connexus which is the managed care organization that
- 944 covers Austin Travis County and us so it'll be a one way to data sharing so we have data that we're able
- to share because it has no protected health information.
- 946 They look at that data and they say all these are well 1.2 million you know files we have 50,000 you
- 947 know matches and then they just take that 50,000 and then they come back to us where so we can be 948 connected to the healthcare case managers.

- 950 And so we connect them to the you know homeless response system case managers so they can work
- together it's just more efficient yeah because sometimes they don't even know that they're still on the
- rolls the person experiencing homelessness they don't know if they have the healthcare and they're not
- 953 taking advantage of it yeah.

- So yeah because I go to emergency rooms and it cost. They get their treatment but it costs the
- 956 community a lot of money when.

958 \$3000.00 every come to the doors open is what JPS tells us.

960 Right and they could be going to their primary care.

- 966 Of course, yeah thanks for having me so Diego Garza with Texas homeless network.

- 968 Want to give you a brief overview of what I've been doing. I started at THN last November and since
- 969 then I've been learning all that is happening the homeless response system what is working for families
- 970 what is not.

- 972 Statewide and within the balance of state and specifically in certain regions so I've been drilling down
- 973 into HMIS data but also talking to communities about what are families experiencing what are the
- 974 obstacles that are keeping them from exiting homelessness and I've developed a few different
- 975 intervention possibilities that we're still in the process of determining which is going to be the best for
- 976 specific families in our Regions.

- 978 But one thing I'm super excited to share is that we've identified a priority population which is families
- with children that are between zero and 5 so they're in this critical development range a lot of studies
- 980 show that children in that range when they're experiencing homelessness have physiological or mental
- 981 health issues.

- 983 Throughout the rest of their lifetime but if you can intervene at that moment you can quell or even
- 984 reverse or stop those effects and from the onset of the project trying to decide what the intervention
- 985 was we wanted to make lasting effects for families so that is our priority population that we've 986 identified.

- 988 And we have a few different interventions that we're honing in on hopefully we will have an
- 989 announcement on what those will be in the coming weeks but yeah as I said we're still determining
- 990 which one is going to work for those specific regions that we're looking into.

992 Cool do you feel like you can say which regions right now. Or is it.

- 994 Yeah I can say so we've been the way that I kind of decided or how we looked at different regions was
- finding where clusters of large families were and then figuring out the funding allocation that maybe
- 996 they haven't had comparatively.

- 998 And we've that's lead us to Sherman, Texarkana, Laredo, McAllen, Hidalgo, and Victoria which is a little
- bit of an outlier in terms of funding but they are in what we've seen in the data they have the highest
- 1000 like their number one in family homelessness across age breakdowns and also just in general
- 1001 population.

- 1012 homelessness.
