I. Welcome and Introductions

- Chair Mike Doyle opened the meeting, confirmed quorum.

II. Remarks from Chair

- Chair Mike Doyle shared reflections on his 36 years of service, noting his likely retirement in 2026 due to health reasons.
- He emphasized the importance of upcoming HUD discussions on rethinking homelessness and encouraged participation.

III. Approval of Minutes from June 25, 2025 TICH Meeting

- Motion to approve previous meeting minutes made by Brooke Boston, seconded by Desiree Viramontes.
- Minutes were approved unanimously.

IV. Continuum of Care (CoC) Updates

- Waco CoC introduced a new lead from Prosper Waco, working to establish a local homeless coalition.
- Eric Samuels (THN) provided updates on the Balance of State CoC:
 - Now includes 214 of Texas's 254 counties.
 - Lubbock County has separated to form its own CoC.
 - 10 of 12 CoCs participate in the Texas Homeless Data Sharing Network.

- Estimated 28,000 individuals were homeless during the 2024 Point-in-Time (PIT) count; annual homelessness estimated at ~65,000.
- PIT count for 2025 will occur in the last 10 days of January.

V. Texas Homeless Network (THN) Updates

- Bezos Family Foundation Project
 - THN received \$2 million in Amazon stock from the Bezos Day 1 Family Fund.
 - Funds support family homelessness initiatives in:
 - Sherman, Texarkana, Hidalgo, Victoria, Laredo, and through Endeavors.
 - Two components:
 - Family Trust: Direct financial assistance to families.
 - Innovation Fund: Grants to local agencies for family homelessness prevention.
 - RFPs have been released; awards expected by the next TICH meeting.
- Planning a Legislative Lunch & Learn on October 15, 2025, to educate Capitol staff on homelessness. Emphasis on aligning data and messaging across agencies to better advocate for funding and policy.
- Discussion on reconciling HUD and TEA definitions of homelessness to improve communication and advocacy.
 - TEA and THN discussed discrepancies between HUD and education definitions.
 - Suggested comparing CoC and school district lists to identify overlaps.
 - Emphasis on unified messaging to policymakers and funders.

VI. Updates from Member Agencies

Texas Department of Housing and Community Affairs (TDHCA)

- Emergency Solutions Grants (ESG) – Brooke Boston
 - 9.81 million awarded across all 12 CoCs.
 - Implementation webinars scheduled for subrecipients covering:
 - Administrative and financial requirements
 - Program compliance
 - Reporting expectations
 - CoCs and HMIS leads invited to contribute regional updates for inclusion in the webinars.
- HOME-American Rescue Plan (HOME-ARP) – Peg McCoy
 - \$133 million total allocation:
 - \$53 million for rental development (12 projects; 6 already open)

- In Austin: Katie Lofts, The Ritz, Burnet Place (PSH for individuals with HIV/AIDS)
- In Dallas Metro: Jaipur Lofts, Bridle Ridge, Lapice Flats (Grand Prairie)
- Additional projects in Houston, Brownsville, Abilene, and two more in Austin
- \$50 million for non-congregate shelter (NCS)
 - Example: The Other Ones Foundation (Austin) received a \$50 million award
 - NCS units include private rooms with bathrooms; some include kitchenettes.
 - Additional awards expected in October 2025
 - Applicants include DV shelters, youth-focused organizations, and specialized providers like Ranch Hands Rescue
- \$3–4 million for nonprofit capacity building

Texas Veterans Commission (TVC) – Gary Medina

- New director: Brenda Keller
- Veterans Homelessness Summit planned for October 2025
- Military Veteran Peer Network now under TVC:
 - 67 peer coordinators and rural veteran counselors statewide
- TVC is hiring for:
 - Homeless Program Manager
 - Justice-Involved Veteran Program Manager
 - Suicide Prevention Manager
 - Rural Community Advocates (remote roles)

Texas Education Agency (TEA) – Desiree Viramontes

- Statewide support network through 20 Education Service Centers (ESCs)
- Launching 1-800 hotline and intake portal in October 2025
- 114,000 students identified as experiencing homelessness in 2024–25.
 - 78,000 reported in PEIMS snapshot (point-in-time equivalent)
- Received \$81 million in McKinney-Vento funds; only \$11 million lapsed.
- 79% of funds go directly to school districts.
- Clarified broader definition of homelessness in education (includes doubled-up, motel/hotel, substandard housing)
- Emphasized need for cross-agency collaboration and data alignment.

- Improving collaboration between education and homeless response systems

- Using shared data to advocate for funding and policy change.
