Scoring Application Log - posted 2/22/22**

This Application Scoring Log lists all eligible non-entitlement communities that submitted an application in response to the CDBG-CV CRP NOFA. The log is sorted by overall rank, which was determined by the total score of the application using the scoring criteria from the CDBG-CV CRP NOFA. Scores were given based solely on the application submitted by each non-entitlement community according to the NOFA scoring criteria. Total funding made available in the NOFA is approximately \$38,100,000. If all applications are funded at 100% of the requested amount, awards may go through the 14th ranked application.

Applicants have the right to appeal a decision made by the Department in accordance with 10 TAC §1.7. Applicants that wish to appeal their score must do so in writing to Rudy Bentancourt at rudy.bentancourt@tdhca.state.tx.us within 7 days of this posting, no later than 5:00 p.m. Austin local time on March 1, 2022. Staff will present the appeal to the Executive Director and a response to the appeal will be provided in advance of the Board meeting of March 10, 2022. If the applicant wishes to appeal the determination made by the Executive Director, upon receiving notification, staff will present the appeal for consideration by the Board at the Board meeting of March 10, 2022. The Board decision is final.
